- (i) To purchase, acquire, own, hold or take on lease any property, movable or immovable, which may be used for the efficient functioning of the trust.
- (j) To accept donations, grants, presents, gifts and other offerings in cash or kind for the attainment of aims and objects of the Trust.
- (k) Funds of the trust shall be invested in securities, units, certificates, debentures or shares as specified u/s 11(5) of the Income Tax Act, 1961.
- (l) All the incomes/ earnings, movable/ immovable properties of the trust shall be solely utilized and applied towards the promotion of its aims and objects only as set forth above and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the members of board of trustees.
- (m) To receive financial and non-financial assistance from Govt. Non Govt. Organization, International Agencies, Bank and any other legal entity or individual

- (n) To erect, construct, alter, maintain, sell, lease, mortgage, transfer, improve, develop, manage and control all or any part of property or building of the above Trust, necessary or convenient for the purpose of attainment of the Aims and Objects of the Trust.
- (o) To invest, dispose of, transfer and, otherwise deal with the properties and assets of the Trust in such manner as the trustees may deem fit, for the attainment of the objects to Trust.
- (p) The activities and the branches shall spread all over in India and also in the different countries of world, where the Trust may decide from time to time.
- (q) To do any other act or thing which is incidental to the achievement of any of the above- stated objects


[9] The Board of Trustees shall appoint employees as and when necessary. It has also the powers to terminate the services of any staff, as it may deem fit and proper for the benefit of the Trust.


[10] It is hereby declared that no part of Trust property or its income shall be applied for any purpose other than the objects of the Trust and surplus funds ,if any, of the Trust shall be invested as per section 11(5) of Income Tax Act.

[11] Number of the Trustees shall not be less than two in number. Trustee shall be the Trustee for their life time but any Trustee may resign by giving in writing to the Managing Trustee one month in advance. Appointment of Trustee(s) shall be only with the final approval of Board of Trustees.

[12] Any Trustee shall cease to be a Trustee on account of one or more of the following reasons;-

- (A) Death
(B) Resignation

(C) Becoming of unsound mind.

(D) Indulging in activities detrimental and prejudicial to the aims and objects or the goodwill of the Trust.

(E) Conviction by a Competent Court of Law for any offence involving moral turpitude.

(F) Relinquishing or forfeiting Indian Nationality.

(G) Absent himself without showing proper cause of explanation from three consecutive Meetings of the Board.

[13] The general management and control of the Trust properties and its affairs shall be vested in the Trustees and the Trustees shall have power to do the all such acts as may be considered necessary for the benefit of the Trust and/or management of its properties and affairs.

[14] Without prejudice to any of the powers that the Trustees may have under any law for the time being in force or to their general powers for the management, the Board of Trustees shall have the following powers:

(a) To manage the Trust, the Trust fund, Trust Property and other affairs relating to the Trust and to do all acts, deeds and things necessary for the preservation, maintenance and management thereof and the affairs relating thereto or connected therewith, including the making of Rules and Regulations from time to time.

(b) To apply any part of the Trust fund in acquiring movable and/or immovable properties and sell, mortgage, alienate or otherwise dispose off the same as they may think fit and proper.

(c) To take on or let out on rent or lease, purchase or construct building and to construct, add, alter, demolish, maintain, sell, dispose off, alienate or otherwise deal with any property comprising the Trust Fund, for the achievements of the objects of the Trust.

(d) To acquire, purchase, vary, sell, convert, change, transfer or otherwise deal with all or any of the investments including shares, stocks, debentures, Govt. Securities belonging to the Trustees or representing the Trust Fund and to re-invest the same as the Trustees may deem fit and proper in accordance with the provisions of Income Tax Act.

(e) To let out, any property comprised in the Trust fund for such period and at such rent as may be considered proper.

(f) To apply for registration and approval u/s 35AC, Section 80G/ Section 12A of the Income Tax Act or under any other statute.

(g) To enter into any contract and borrow money to carry out the objectives of the Trust and management of its properties and assets.

(h) Managing Trustee together with Executive Trustee/s would be authorized to open and operate bank account/s whether singly or jointly and issue such directions from time to time to the bankers required in relation to operation of the bank account.





- (j) To institute suits, actions and legal proceedings, to prefer appeals, to make applications or petitions, and to give affidavits, wherever necessary and to defend or compound, compromise, abandon, submit to arbitration or otherwise settle any suit, action claim, legal proceedings, appeal, demand or dispute relating to the Trust.
- (k) To keep proper accounts of the Trust Fund and its property.
- (l) To apply whole or any part of the Trust Fund (corpus and/or income) or property for the objective and purpose of the Trust and to set apart the whole or part of the income of the corpus or part thereof for any of the objects of the Trust.
- (m) To amalgamate the Trust with other institution, association, Trust or organization having Public Charitable objects and purpose with the consent of two third of Trustees in writing.
- (n) To nominate, appoint and designate attorney(s), agents, legal practitioners and office bearers and employees and to delegate the duties and powers vested in them (Trustees) with regard to the management of the Trust property including starting or defending of legal proceeding or for opening or operating upon accounts with any bank(s), person(s), firm(s), or to do such other acts and duties relating to or connected with the Trust property as may be deemed necessary.

(o) To appoint/nominate patrons and to give such other designations to various persons extending help for the running or for the causes of the Trust.

(p) And generally to do all acts, deeds and things as may be necessary for administration of the Trust.


[15] For the time being, Trustees will not be entitled to receive the remuneration as Trustees but may reimburse themselves of all expenses actually incurred by them on behalf of the Trust. Trustee/s performing duties/ functions as employee/s of the trust shall be entitled to receive remuneration as deemed appropriate on approval of Board of Trustees.


[16] The Board of Trustees may, from time to time, frame Rules for the administration and management of the Trust and for regulating the meeting of Trustees. In the absence of such regulations:

- (i) all the matters will be decided by majority and the quorum for the meeting shall be two third,
- (ii) a resolution circulated to all Trustees and signed by the majority of such Trustees shall be a valid and effectual as resolution duly passed at a meeting of the Trustees.

[17] That regular accounts will be maintained relating to all receipt, payments, income, expenditure or any property or liabilities relating to the Trust. Further, the accounts of the Trust will be audited by a Chartered Accountant. The accounting year of the trust shall be the financial year ending on 31st March every year.

[18] The bank account of the trust shall be with such bank or banks as may be mutually decided from time to time by board of trustees and the same shall be operated by the Managing Trustee.

[19] The Board of Trustees shall be entitled to sue in the name of Trust and may similarly be sued in the name of Trust. In the event of any dispute the matter will first be referred to arbitration and arbitrator shall be the person acceptable to both the parties.

[20] It is expressly declared that no part of the trust property or its accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable in law, and all provisions hereof shall be construed accordingly.
